For classifications paying (\$2.10) Dues, such dues are comprised of District Council 16 dues check-off of (\$.95) and Union Local 250 Dues of (\$1.15). Classifications paying (\$1.45) Dues, such dues are District Council 16 dues check-off of (.95) and Union Local 250 Dues of (.50) (****) Refer to 11.02-F for Probationary Period application													
NOTE: The Employer shall pay to the ARCA/MCA Promotion Fund \$.35 per hour worked for all classifications under this Agreement. That amount, which will be included in the "Composite Rate" is to be sent to the Joint Trust Depository.
