

Of those Dues, Administrative Dues of (\$1.20) for First Year Apprentices and (\$1.70) for all other classifications will be sent from the Joint Trust Depository directly to District Council 16. First Year Apprentice Dues of (\$1.20) is comprised of District Council Dues Check-Off of (\$.55) plus (\$.65) Local Union Dues. All other classifications Dues of (\$1.70) are comprised of District Council Dues Check-Off of (\$1.05) plus (\$.65) Local Union Dues.
